### **President's Report**

### The Hon. Justice George Palmer

# 2004

As a very recent newcomer to the board of the Arts Law Centre of Australia, I would first like to pay tribute to the outgoing president, the Hon Justice David Levine. David Levine led Arts Law for 10 years and the company will always be indebted to him for his long and successful stewardship. The Board was delighted to appoint him to the Council of Patrons in recognition of his outstanding service to Arts Law.

Arts Law depends upon vital funding support from our principal funding partner, the Australia Council for the Arts and on the ongoing support of the Australian Film Commission, the NSW Ministry for the Arts, Arts SA, Arts WA and the Copyright Agency Limited (CAL). We owe a great debt of gratitude to those bodies. However, it is becoming increasingly important for arts organisations, as well as community legal services, to be creative in the way they go about their fundraising. This involves developing new relationships and partnerships with Government, in the arts and in the legal and business worlds. Given that Arts Law has been providing legal and business advice to the Australian arts community for 21 years and has assisted thousands of artists at different stages of their careers, I am interested in exploring the opportunities for established artists to contribute to Arts Law by participating in events organised by Arts Law to develop wider relationships within the legal and business communities.

I would hope also that Board members themselves can play an active role in raising the profile of the company and increasing our income base so that Arts Law can continue to respond to the ever increasing demand for its services within the Australian arts community.

One such service that Arts Law established in 2004 is Artists in the Black, a service tailored to meet the need of Indigenous artists and their communities. Although the project is still in its pilot phase, Arts Law will be working with its stakeholders to ensure the service continues after the initial two-year funding period.

In my short time on the Board I have been greatly impressed by the enthusiasm and professional dedication of our staff. Arts Law could not continue without their willingness to give more than can reasonably be asked of them. I am also heartened to see the pro bono support provided by the legal community to Arts Law and the Artists in the Black project. Lawyers generously give up their time to provide advice to artists and to assist in educational work; law firms assist by hosting events. I will be interested in exploring other ways in which the legal profession, and perhaps the accounting profession as well, can work with Arts Law to maximise the services we provide to Australia's artists.

Finally I would like to pay warm tribute to Robyn Ayres, the Executive Director, who in her two and half years at Arts Law has succeeded in bringing about a dramatic improvement in the financial position of the company. She has created a stimulating and productive environment for all, staff and Board members alike, and I am delighted to be working with her. Under Robyn's guidance and with a committed Board, ALCA is ready to look forward and meet new challenges.

### **Executive Director's Report**

### Robyn Ayres

saw a changing of the guard at Arts Law with our long serving President, the Hon Justice David Levine retiring after 10 years of dedicated service to Arts Law. On behalf of the staff and board, I would like to acknowledge the enormous contribution Justice Levine has made to Arts Law over the years. We are also very privileged to be able to welcome our new President, the Hon Justice George Palmer, who is not only a judge of the Supreme Court of NSW but also a renowned composer. So it is an exciting new era for Arts Law.

And what could be more exciting than the establishment and launch of the Artists in the Black service. Artists in the Black is the name of the Indigenous service provided by Arts Law which is staffed by Blanch Lake, the Aboriginal Information Liaison Officer and Samantha Joseph, the Aboriginal solicitor. The aim of the service is to provide Arts Law services in a more accessible way to Indigenous artists and their communities. Artists in the Black was launched on 28 June 2004 and by the end of the year we had provided legal advice and casework services to over 100 Indigenous artists and organisations throughout Australia. In addition Artists in the Black presented 18 educational workshops or seminars in 12 locations, and at 4 Indigenous conferences. In all we reached over 800 people throughout Australia. This included a 2 week tour of regional Western Australia which we were able to do as a result of funding from Dept of Consumer and Employment Protection WA and Copyright Agency Ltd (CAL).

In 2004 Arts Law increased our overall focus on education delivering specialised sessions to artists across most art forms. We also held Arts Law Weeks in Perth and the Northern Territory and over the year delivered educational sessions to over 2000 creative people around Australia.

Arts Law also managed to increase both the number of legal advices provided (to 2410) and the number of face-to-face Legal Advice Night appointments with our panel of specialist lawyers (to 346). This was only possible due to the efforts of the very dedicated staff at Arts Law, both legal and administrative, and whilst singling individuals out is difficult in view of how much everyone does, I would like to acknowledge the support provided by our very capable Administration Manager, Garey Campbell, and the huge pro bono contribution he makes on a weekly basis in order that everything runs as smoothly as possible.

I must say by the end of 2004, we were all pretty exhausted, and it is probably unrealistic to continue to expect staff who are underpaid and overworked to keep doing it for long periods of time. Inevitably this leads to staff turnover at higher than desired levels and is a problem that Arts Law will continue to face. With insufficient core funding, Arts Law must find new projects and other ways to supplement our income that can be exciting but also further stretches the staff. Of course the pro bono contributions of lawyers and law firms around Australia are extremely valuable and also help extend the Arts Law dollar. However I would like to pay special tribute to Middletons who have provided Arts Law with a lawyer one day/week for the whole of 2004.

### **Arts Law**

The Arts Law Centre of Australia (Arts Law) is the national community legal centre for the arts. Arts Law is a not for profit company limited by guarantee. Arts Law was established with the support of the Australia Council in 1983 to provide specialised legal and business advice and referral services, professional development services and advocacy for artists and arts organisations.

Arts Law provides legal advice and information on a wide range of arts related legal and business matters including contracts, copyright, business structures, defamation, insurance, employment and taxation to artists and arts organisations across all art forms.

The majority of Arts Law subscribers are individual arts practitioners – including visual artists, authors, new media artists, performers, musicians, composers, writers, film and documentary makers, choreographers, graphic designers and set designers.

#### **Vision**

To foster a society which promotes justice for artists and values their creative contribution.

#### **Mission**

To provide practical, specialist legal services and resources, (including advocacy, publications and education), to artists and the cultural sector.

#### **Values**

# National Legal Advice, Referral and Mediation Services

The focus of all of the work of Arts Law is to ensure that the creative and cultural sector of Australia have access to practical, specialist legal services and resources.

Arts Law provides legal advice on a wide range of legal and business issues affecting artists and the cultural sector including copyright, contract, moral rights, performers rights, trade marks, passing off, trade practices, confidentiality, employment, defamation, business structures, privacy, insurance, censorship and taxation.

Arts Law provides a free national telephone legal advice service to the arts community and, to Arts Law subscribers, extended legal advice service, national face-to-face legal advice Legal Advice Nights and pro bono referrals. Arts Law also provides referrals to our panel of mediators on a fee for service basis.

In 2004 the number of occasions on which telephone advice was provided was 2401, an increase of 10.4% (226 advices) over the previous year's 2175.

#### **Legal Advice Nights**

Subscribers to Arts Law can attend Legal Advice Nights for face-to-face advice, or telephone consultations for up to two hours with experienced specialist lawyers who are on Arts Law's panel. Lawyers from large corporate and boutique firms, as well as government and in-house lawyers, volunteer for the national Legal Advice Nights panel. In 2004 Arts Law had an extensive national panel of 194 pro bono lawyers.

#### Coverage

Face-to-face Legal Advice Nights (LANS) operate in Sydney, Melbourne, Adelaide, Hobart, Perth, Darwin, Alice Springs and Canberra. Subscribers in other cities and regional areas can access extended telephone advice with lawyers on our panel.

In June Arts Law received funding through the Australia Council to upgrade the website, and include an e-commerce facility. It is proposed the new site will be launched early 2005.

### **Education Program**

In 2004 Arts Law's legal staff presented an extensive program of lectures, workshops and seminars on topical issues concerning law and the arts as well as delivering papers at a range of conferences. In all Arts Law reached over 2249 creative people around Australia.

#### **Lectures and Seminars**

Arts Law continued to run its lecture program, presenting at the following universities and art schools during the year:

Lectures covered topics such as copyright and design law, contracts, moral rights, obscenity laws, defamation, employment issues, business issues such as superannuation, tax and insurance and other issues specific to the participants needs. Most of these lectures are provided on a fee-paying basis.

Many of the events were delivered in partnership with other organisations, which assisted with the promotion, and many of the events were free or low cost. Arts Law notes that the national educational program has been made possible through a funding partnership with the Copyright Agency Limited.

Arts Law also presented at a range of conferences throughout the year, delivering 8 presentations at 7 conferences which had an overall attendance of 780 participants.

### **Artists in the Black**

In 2004 Arts Law received funding from the Australia Council to trial an Indigenous Project to improve service delivery to Indigenous artists and their organisations across Australia. The project is called Artists in the Black and aims to increase Indigenous access to advice and information about their legal rights on all arts related matters. The project was launched on 28 June 2004, is currently in its pilot stage and will be trialled for 2 years.

Arts Law has employed 2 Aboriginal staff, Samantha Joseph, in the lawyer's position and Blanch Lake, as the information/liaison officer. To date the focus of the project has been

- Providing direct legal advice to individual Indigenous artists on their arts law problems;
- Providing information and education about arts law issues to ensure Indigenous artists are informed about their legal rights

Artists in the Black is designed to:

- Address the structural disadvantages that some Indigenous people may encounter in having their needs for legal advice, information and education met;
- Be non-threatening and responsive to the special circumstances of some Indigenous artists and their communities;
- Consult with Indigenous artists and organisations as to the best methods of delivering legal advice and information services to Indigenous artists;
- Develop the resources needed by Indigenous artists and organisations in response to consultations;
- Develop the skills of Indigenous staff employed on the project (legal and other) so they become a future resource for Indigenous artists and their communities;
- In response to the feedback received from Indigenous artists, organisations and communities and other stakeholders recommend a model to provide ongoing access to legal advice, information and education services.

#### Reference Group

A Reference Group has been established from the Indigenous community to provide support and guidance throughout the course of the project. The current members of the group are:

The Reference Group met 3 times in 2004 have provided feedback on issues such as promotion of educational workshops, development of educational materials and the plan for the service for 2005.

#### **Legal Service Provision**

The Indigenous staff work with the other Arts Law staff to provide enhanced services to the Indigenous community. Whilst the service was only launched at the end of June, in 2004 over 100 legal advices, face-to-face consultations and casework services were provided. The AITB staff have liaised with other legal and arts organisations, particularly Indigenous organisations, to raise awareness about the services provided under the project and to ensure that appropriate referrals are made to and from the project.

AITB staff have full access to the pro bono panel lawyers and referral lawyers that Arts Law already has in place. Given the need for ongoing casework services in some matters we have also been able to put in place pro bono lawyers willing to provide this extended service. Firms that have made an additional commitment to the project are:

The sample agreements developed by Arts Law are a very useful resource for artists and the art community. In 2004 AITB worked with the Federation of Aboriginal and Torres Strait Islander Languages (FATSIL) to develop a contract for use in Indigenous language projects. AITB will examine the need for the development of further sample agreements particularly in relation to Indigenous Culture and Intellectual Property (ICIP).

#### **Public Interest Casework**

The Indigenous lawyer in consultation with Arts Law's senior lawyer and the Executive Director identifies cases requiring ongoing casework. These cases have a public interest component that will benefit the Indigenous community more broadly, particularly in further recognition of ICIP issues. To date there has been ongoing casework in six matters.

#### **Subscription Fees**

Arts Law is conscious of the fact that many Indigenous artists needing our service may not be able to pay the subscription fees for extended services. For the duration of the pilot phase (to the end of 2005) Arts Law is subsidising the subscription for Indigenous artists and organizations.

# **Development of Accessible Educational Materials about Artists Rights**

Arts Law developed information sheets which were trialed during the WA trip in September 2004. The information sheets developed and distributed were:

- Copyright
- Moral rights
- Indigenous Culture and Intellectual Property
- Licensing
- Contracts
- Business structures
- Governance
- Certificates of Authenticity

Arts Law is now working with Streetwize Publications to develop a coloured and illustrated version of four of the information sheets. These will be published in April 2005.

## **Delivery of education program to empower Indigenous creators**

In 2004 AITB developed and delivered an education program to Indigenous artists and their organisations across Australia. The sessions were held in 16 locations and over 800 participants attended The Artists in the Black workshops took place in the following locations:

Melbourne (12-13 February and 23-24 September)

Townsville (17-18 June)

Western Australia (12-24 September)

Northern Territory (11-15 October 2004, 18-19 November, 1-3 December)

South Australia (25-26 November 2004)

#### Advocacy

AITB, although busy providing legal advice and educational services, has also had input and provided advice to Indigenous organisations and Government on the following issues:

Indigenous Culture and Intellectual Property, including communal moral rights

- Commonwealth funding agreements for Indigenous organisations.
- Proposed legislation on Indigenous communal moral rights
- Better recognition of ICIP under Australian law

#### Resale royalties

Arts Law, together with advocacy partners, is seeking an introduction of resale royalties in Australia.

Given the success of Artists in the Black to date Arts Law will be seeking funding to ensure the continuation of the service beyond its pilot phase.

### **Advocacy and Law Reform**

The advocacy goal of Arts Law is to provide targeted, quality advocacy on law and policy reform, for the benefit of the creative sector. This is done through

- 1. Identification and prioritisation of issues affecting the arts community
- 2. Research and making of submissions
- 3. Developing relationships and with the Government, media, arts sector and other relevant bodies;
- 4. Lobbying to influence the decision making of Government and other bodies.

#### **Advocacy Subcommittee**

The Arts Law advocacy subcommittee comprised of Board members (Vivien Johnson, Jill McKeough, Andrew Kenyon and Robynne Quiggin) and staff members met on 2 occasions in 2004 and legal staff met another 5 times.

The Advocacy subcommittee worked in accordance with its 2004 Advocacy Plan.

During the year Arts Law responded to a range of issues that arose as well as continuing with the planned advocacy work.

#### **Submissions**

Arts Law made the following submissions to Governments and other bodies:

- to the Board of Taxation on the non commercial loss provisions in the Income Tax and Assessment Act;
- to Government on the introduction of Resale Rights (in partnership with Australian Copyright Council, NAVA and Viscopy)
- to JSCOT and as a member of the Australian Coalition for Cultural Diversity to Government on the US Free Trade Agreement
- to the Attorney General on Crown copyright
- to ACCC on APRA's arrangements
- to CAL on its distribution policy
- to Screenrights on its distribution policy
- to ATSIS on Indigenous funding agreements
- to the Australian Tax Office to finalise the public ruling on the meaning of carrying on a business as a professional practising artist for the purposes of the Income Tax and Assessment Act (in partnership with NAVA on behalf of the arts community).

#### **Advocacy Partnerships**

Arts Law has worked with a number of other organisations and individuals in order to maximise the effectiveness of the advocacy work of the centre. Significant partnerships in 2004 were with

- NAVA on behalf of the arts community on the taxation issues;
- Australian Copyright Council, NAVA and Viscopy on the introduction of a resale right;
- Australian Coalition for Cultural Diversity, comprised of key membership and service organisations across
  the cultural sector on need to ensure that the Free Trade Agreement with the US does not jeopardise
  culture.

#### Lobbying

To further the advocacy work of Arts Law, legal staff participated in meetings with the following Government Departments, Ministers and stakeholders:

- Meeting with the Rulings Panel of ATO on draft public ruling in partnership with advocacy partners National Association for the Visual Arts (Tamara Winikoff), pro bono tax consultants Judy Sullivan and Jill Savage of Mallesons Stephen Jaques, Delia Browne and staff of DCITA.
- Meeting with advisor to Darryl Williams, Minister for Information Technology and the Arts.
- Meetings on Indigenous communal moral rights: with Indigenous stakeholders
- Meetings with Indigenous organisations and representatives from ATSIS on Government funding agreements.

#### **Pro Bono Support**

Arts Law acknowledges the significant pro bono assistance provided to Arts Law and NAVA by tax consultants, Judy Sullivan and Jill Savage of Mallesons Stephen Jaques, as well as the ongoing support of lawyer Delia Browne.

### **Volunteers and Pro Bono Assistance**

Volunteers and pro bono lawyers are integral to the provision of Arts Law services. The Arts Law volunteers perform the following valuable tasks:

#### **Volunteer Lawyers**

Arts Law receives considerable pro bono assistance from the legal profession in addition to the national face-to-face legal advice night service. Some of the services provided by our volunteer lawyers include the provision of advice to our lawyers when a matter is outside our expertise; writing articles for Art + Law; as well as reviewing our sample contracts and other publications.

Examples of such assistance in 2004 include:

#### **Panel Lawyers**

The lawyers who provide pro bono advice to Arts Law's subscribers at our Legal Advice Nights are referred to as Panel lawyers. In 2004 Arts Law had a panel of 194 lawyers throughout Australia ranging from large corporate law firms, government and in-house counsel, boutique law firms and individual practitioners. The Legal Advice Night service is an important part of the legal services provided by Arts Law and we acknowledge the significant contribution made by the legal profession to the arts community in this regard.
